### President's welcome

Approval of Minutes: Motion moved by Simon and seconded by Jennifer. Approved.

## **Committee and Program Reports:**

- Racing (Artem) active racing season introducing new racing bibs next year
- John Darling special report
- LTW (Simon) 400 sessions and over \$100k revenue
- Coop program (Simon) 20 members generated \$15k revenue
- Youth camp & high-performance program (Max) another good year, great leadership from Deeni
- Level the Playing Field (Max) goal to get BIPOC community in to windsurfing. Partnered with Brown Girl Outdoor World and offered 4 sessions plus welcome BBQ. Sold out in less than a day. Also partnered with BGC and Kiwanis to get kids with lower incomes into the program. Club sponsored 32 campers at no cost in keeping with our service to the community mandate
- Gardening (Jennifer) removed invasive species and planted native species. Call out for a gardening coordinator.
- Safety (Jennifer) working with OHSF safety committee and FOCBOH.
- Physical Site (Tony) keeping in good shape. Reviewed storage needs and based on member adoption of alternate sailing style – such as foiling, the club probably has sufficient space in our current containers. Colin Thomas applauded for his ongoing contribution to the upkeep of the club and grounds
- Thanks expressed to Jerry Caplan for many years in support the management of the club's storage
- Community Relations (Jennifer) beginning to plan for lease renewal in 2025, and also in conversations with Waterfront Toronto, Waterfront Secretariat, Harbour master and Toronto Marine Unit
- Marketing & Communications (Jennifer) worked with Hole to develop branded clothing, and now developing flags.
- Volunteers always looking for volunteers

**Auditor Report**: Michael Keltz – present results for 2021 ending December 21, 2021. Unqualified auditors report. In 2022, revised policy to improve process. 2021 improved revenue situation compared to 2020 which was impacted by COVID. TWC is in good position. Planning to do audit in Q1 2023. Financials were approved by Board in 2022.

**Treasurer's Report**: Emily Deeth – Club remains in a healthy financial situation. Revenues a little lower than 2021, but still strong. Investments made in club boats and motors. Also, invested in new rigs and boards. Need to repay \$30k loan from CEBA for covid.
